#### Veterans' Resource Center Donations

- Curtis Sheetz took the naming opportunity for the plaza near the VRC which consisted of a \$300,000 donation. The Plaza will be named Total Environmental Management, Inc.
- The College a \$100,000 donation from Forest Lawn
- The College received a \$100,000 VRC grant from the state.

# Hunger Taskforce

- Dr. Schilling attended a Hunger Taskforce meeting with other community college CEOs on October 24. There were discussions about the possibility of some community colleges having dorms.
- Dr. Schilling is discussing the possibility of creating a plan with YBH where students could purchase food using a meal voucher from the College.

There are concerns about the heavy use of lot 7, which will be reduced once construction begins and led to increased parking in lot 8.
